Supervise recruit and hire staff and schedule work hours. Direct the client admission process and treatment, rehabilitation and support services of the program. Provide clinical supervision. Execute and document quality assurance activities. Participate in providing treatment and dual diagnosis services. Will be part of the on call clinical treatment team and will rotate on-call duties with team members.

The ideal candidate will have a clear understanding of the characteristics and problems of adults with severe and persistent mental illnesses and will be knowledgeable about the ACT model.
